WHEREAS, presented for consideration is the Supplemental Investment Program No. 7 of the Province of Pangasinan for Calendar Year 2024 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 10-24;

WHEREAS, Supplemental Investment Program No. 7 contains other priority programs, projects and activities that were not included in the approved 2024 Annual/Supplemental Investment Program of the Province of Pangasinan;

WHEREAS, the programs and projects included in the said Supplemental Investment Program covers fund augmentation for Personal Services, Capital Outlay and Maintenance and Other Operating Expenses of provincial offices and hospitals and implementation of other priority programs and projects of the Province to be funded under Special Purpose Appropriations;

WHEREAS, said Supplemental Investment Program also covers the implementation of project to be funded from the Seal of Good Local Governance Incentive Fund (SGLG IF), Pangasinan being a passer of the CY 2024 SGLG Assessment;

WHEREAS, also embodied in the said program is the granting of additional Service Recognition Incentive (SRI) for qualified provincial government employees, construction/repair/rehabilitation of various roads and bridges and other infrastructure development and support projects;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


