PROVINCIAL RESOLUTION NO. 1207-2024

INDORSING THE PROPOSED CONSTRUCTION AND REHABILITATION OF RIVER SLOPE/BANK PROTECTION STRUCTURE AT TEN BARANGAYS IN MANGATAREM, PANGASINAN DUBBED AS THE "MANGATAREM FLOOD CONTROL PROJECT"

WHEREAS, RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010, mandates the development, promotion, and implementation of a comprehensive disaster risk reduction and management program at the local government level:

WHEREAS, Section 2 (d) of RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010 provides the adoption of a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socio-economic and environmental impacts of disasters including climate change, and promotes the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community;

WHEREAS, Section 12 (8) of RA 10121 mandates Local Disaster Risk Reduction and Management Office (LDRRMO) shall conduct continuous disaster monitoring and mobilize instrumentalities and entities of the LGUs, CSOs, private groups, and organized volunteers to utilize their facilities and resources for the protection and preservation of life and properties during emergencies in accordance with existing policies and procedures;

WHEREAS, the Province of Pangasinan has been determined in defining its role in continually and responsibly implementing policies, programs and projects aimed towards the development and improvement of disaster risk reduction and management in the Province;

> WHEREAS, the Province of Pangasinan, through the Provincial Disaster Risk Reduction and Management Council (PDRRMC), led by the Provincial Governor Ramon V. Guico III, in full support of the above-endeavor, has approved Resolution No. 6, S-2024 Proposing the Construction and Rehabilitation of River Slope/Bank Protection Structure at Ten Barangays in Mangatarem, Pangasinan Dubbed as the "Mangatarem Flood Control Project";

> WHEREAS, the Municipality of Mangatarem is one of the flood prone areas in the Province of Pangasinan and Barangays Dorongan Linmansangan, Bunlalacao, Bogtong Silag, Dorongan Punta, Dorongan Sawat, Pampano, Olo Cagarlitan, Olo Cafabrosan, Baracbac, and Macarang were the most affected barangays in the said municipality during the onslaught of Typhoon Enteng wherein 1,212 individuals were displaced, based on the Situational Report submitted by the Mangatarem MDRRMO;

> WHEREAS, there is a need to mitigate the increasing flood risks in the municipality due to climate change, heavy rainfall, and water releases from the San Roque Dam, and the present state of the old and inadequate existing flood control structures in the area;

> WHEREAS, the Mangatarem Flood Control Project is a solid and sustainable flood control dike system that would prevent flooding and make the communities and people of Mangatarem, including its infrastructure and agriculture more resilient to calamities;

> WHEREAS, the Sangguniang Panlalawigan indorses the implementation of the Project in order to achieve a holistic and sustainable approach to disaster risk reduction and management in the municipality;

> NOW, THEREFORE, on motion of SP Members Salvador S. Perez, Jr., Philip Theodore E. Cruz and Haidee S. Pacheco, duly seconded, it was -

> **RESOLVED**, by the Sangguniang Panlalawigan of Pangasinan to indorse, as it is hereby indorsed, the Proposed Construction and Rehabilitation of River Slope/Bank Protection Structure at Ten Barangays in Mangatarem, Pangasinan dubbed as the "Mangatarem Flood Control Project";
