DECLARING MUNICIPAL ORDINANCE NO. 179, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF A PORTION OF PANGASINAN-NUEVA VIZCAYA ROAD INFRONT OF THE MUNICIPAL COMPLEX, PORTIONS OF ZAMORA STREET, YLARDE STREET, MAGSAYSAY STREET AND LUNA STREET TO COMMENCE ON FEBRUARY 22 TO MARCH 15 OF EVERY YEAR DURING THE ANNUAL CULTURAL CELEBRATION IN THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 179, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 21 (a) (c) of R.A. No. 7160 and Article 43 of its Implementing Rules and Regulations;

WHEREAS, the Local Government Unit of San Nicolas, Pangasinan shall provide for alternate routes during the temporary closure of the Pangasinan-Nueva Vizcaya Road infront of the Municipal Complex;
