APPROVING SB RESOLUTION NO. 51, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 03, FY 2024 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO ONE MILLION, SIX HUNDRED FIFTY-FIVE THOUSAND, FIVE HUNDRED FOURTEEN PESOS AND FOURTEEN CENTAVOS (P1,655,514.14) FUNDED FROM THE REVERTED MUNICIPAL DEVELOPMENT FUNDS OF 2024, 2023 AND 2022"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Resolution No. 51, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. In consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991, the Local Development Council of Bani, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 3 CY 2024. This was endorsed to the Sangguniang Bayan on September 19, 2024 through MDC Resolution No. 2024-06 and was favorably acted upon by the Sangguniang Bayan on October 21, 2024 through SB Resolution No. 51, S-2024; and

2. The SIP No. 03 covers fund augmentation for Maintenance and Other Operating Expenses and implementation of priority development projects of the LGU. The identified programs/projects are based on DBM-DOF-DILG Joint Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 51, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving SB Resolution No. 51, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Supplemental Investment Program No. 03, FY 2024 of the Municipality of Bani, Pangasinan amounting to One Million, Six Hundred Fifty-Five Thousand, Five Hundred Fourteen Pesos and Fourteen Centavos (P1,655,514.14) funded from the reverted Municipal Development Funds of 2024, 2023 and 2022";
