**RESOLUTION NO. 21-2025**

**APPROVING SB RESOLUTION NO. 59, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 04, FY 2024 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO ONE HUNDRED FIFTEEN MILLION PESOS (P115,000,000.00) FUNDED THROUGH A BANK LOAN WITH THE LANDBANK OF THE PHILIPPINES”**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Resolution No. 59, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 4 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on November 7, 2024 by the Municipal Development Council through Resolution No. 2024-09. This was favorably acted upon by the Sangguniang Bayan on November 11, 2024 through SB Resolution No. 59, S-2024;

2. Said SIP No. 4, with an investment requirement of PhP115,000,000.00, covers the implementation of various development programs/projects/activities (PPAs) to be funded from the LGU's approved Land Bank of the Philippines (LBP) loan/borrowing; and
3. It is humbly recommended that the LGU shall prepare Supplemental Budget to support the full implementation of the identified projects in this subject Supplemental Investment Plan.




