#### **RESOLUTION NO. 22-2025**

APPROVING MUNICIPAL RESOLUTION NO. 197-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 04, SERIES OF 2024 OF THE MUNICIPALITY OF ANDA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Resolution No. 197-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

- 1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Anda, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 04, Series of 2024. This was endorsed to the Sangguniang Bayan for approval on November 6, 2024 by the Municipal Development Council through MDC Resolution No. 07, Series of 2024;
- 2. Said SIP covers fund augmentation for Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices, and the implementation of other priority projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP46,500,000.00 is embodied in their proposed Supplemental Budget No. 4 for Calendar Year 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 04, Series of 2024 on November 21, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;
