RESOLUTION NO. 30-2025

APPROVING RESOLUTION NO. 177, S-2024 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2025 OF THE MUNICIPALITY OF INFANTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its SB Resolution No. 177, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Infanta, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2025, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 9, Series of 2024, dated October 10, 2024. This was subsequently approved by the Sangguniang Bayan through Resolution No. 177, Series of 2024, dated October 21, 2024;
- 2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01, dated July 23, 2015 as to format and content. The AIP of Infanta, Pangasinan was formulated following the prescribed AIP Summary Form categorized into

general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenditures, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Nutrition Action Plan, Culture and Arts Development Plan, Local Youth Development Plan, Local Climate Change Plan; 2) list of programs/projects/activities for Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome, and PPAs on Anti-Drug Abuse;

- 3. The proposed AIP has a total investment requirement of PhP311,654,221.92.00, out of which PhP238,230,068.00 will be funded from the municipality's proposed 2025 Annual Budget enacted on October 21, 2024 through Appropriation Ordinance No. 04, Series 2024. The rest will be funded under the Special Education Fund (SEF) amounting to PhP1,500,000.00 and from other sources/external sources amounting to PhP71,924,153.92;
- 4. The development fund amounting to Php41,095,013.60, which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php205,475,068.00 for CY 2025. This is in accordance with Section 287 of RA 7160;
- The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
- 6. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php10,941,503.40, conforms to Section 21 of RA 10121. The programs/projects/activities to be funded from the 70% of the LDRRMF amounting to Php7,659,052.38 are based on the NDRRMC-DBM and DILG Joint Memo Circular (JMC) No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund) and the 30% amounting to Php3,282,451.02 is allocated for Quick Response Fund (QRF).

It is respectfully recommended that the LDRRM Plan be submitted to the OCD for review as provided under Item No. 2.2.12 of the Department of Budget and Management (DBM) – Local Budget Memorandum (LBM) No.77 dated May 15, 2018 and DBM Local Budget Memorandum Circular No. 82 dated June 14, 2021;

- The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
- 8. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 27, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Infanta, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 177, S-2024 of the Sangguniang Bayan of Infanta, Pangasinan, entitled "Approving the Annual Investment Program (AIP) for CY 2025 of the Municipality of Infanta, Pangasinan";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Infanta, Pangasinan, for its information and guidance.
