**APPROVING RESOLUTION NO. 145-2024 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR FISCAL YEAR 2024 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Resolution No. 145-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. The Municipal Development Council of Urbiztondo, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2024. This was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 03, S-2024 dated October 11, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱12,036,243.17, covers the augmentation of funds for Personal Services (First Tranche Salary Adjustment to all Municipal Officials and Employees and Other Personnel Benefits), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices of the LGU, and implementation of LDRRM programs/activities and other priority projects of the municipality;

3. The projects proposed to be funded from the 5% LDRRM Fund are based on the Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

Likewise, the project proposed to be funded from the 20% Development Fund conforms with Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

Also, the projects/items proposed to be funded from the 20% Share of the LGU in the Fire Code Fees (FY 2015, 2018, 2020, 2021 and 2022) are based on DBM DILG-DOF JMC NO. 1, S. 2023 dated April 17, 2023 (Revised Guidelines on the Release of the 20% Shares of LGUs in the Fire Code Fees); and

4. Funding support for the full implementation of the Supplemental Investment Program is embodied in the LGU's Supplemental Budget No. 2 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2-2024 dated October 14, 2024.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


