#### APPROVING RESOLUTION NO. 2024-223 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4, CY 2024 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2024-223 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- The Municipal Development Council of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 4, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 8, Series of 2024 dated September 4, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- Said Supplemental AIP, which has an investment requirement of ₽5,144,323.00, covers the Implementation of the First Trance of the Modified Salary Schedule for LGU Personnel; and

> 3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 4, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-04 dated November 15, 2024 and was approved by the Municipal Mayor on November 21, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;
