RESOLUTION NO. 53-2025

DECLARING MUNICIPAL ORDINANCE NO. 2024-04 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE TRANSFERRING THE POSITION OF ADMINISTRATIVE OFFICER IV (FINANCIAL ANALYST II) FROM THE OFFICE OF THE MUNICIPAL ACCOUNTANT TO THE OFFICE OF THE MUNICIPAL MAYOR WITH A NEW PARENTHETICAL TITLE OF HUMAN RESOURCE MANAGEMENT OFFICER II IN THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


Municipality of Alcala, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
