DECLARING MUNICIPAL ORDINANCE NO. 2024-04 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED **POSITION** ORDINANCE TRANSFERRING THE ADMINISTRATIVE OFFICER IV (FINANCIAL ANALYST II) FROM THE OFFICE OF THE MUNICIPAL ACCOUNTANT TO THE A NEW THE MUNICIPAL MAYOR WITH OFFICE OF TITLE **HUMAN** RESOURCE **PARENTHETICAL** OF MANAGEMENT OFFICER II IN THE MUNICIPALITY OF ALCALA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
