RESOLUTION NO. 56-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF BAUTISTA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P6,480,738.37, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of Php6,480,738.37 which was enacted on December 9, 2024 through Appropriation Ordinance No. 3, S. of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the said supplemental budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

- 3. That the grant of Service Recognition Incentive (SRI) for FY 2024 to all municipal officials, regular and casual employees of the municipality shall be in accordance with the provisions of Administrative Order No. 27 dated December 12, 2024; and
- 4. That the grant of Gratuity Pay for FY 2024 to Contract of Service (COS) and Job Order (JO) shall be in accordance with the provisions of the specific guidelines to be issued by proper authority.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2024 of Bautista, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bautista, Pangasinan, for its information and guidance.
