RESOLUTION NO. 58-2025

APPROVING RESOLUTION NO. 2024-255 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED “APPROVING THE 2ND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM-CY 2024 OF THE MUNICIPALITY OF SISON, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its SB Resolution No. 2024-255 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sison, Pangasinan has identified items in their Supplemental Annual Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on August 30, 2024 by the Municipal Development Council thru Resolution 07-2024;
2. The SAIP covers fund augmentation for the Personal Services (implementation of the First Tranche Salary adjustment), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of some municipal offices and implementation of priority projects of the LGU Sison; and

3. Funding support for the full implementation of the same in the amount of Php 8,610,000.00 is embodied in their Supplemental Budget No. 2 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2, Series of 2024 on September 2, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sison, Pangasinan;


