**APPROVING RESOLUTION NO. 2024-190 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3, C.Y. 2024 OF SUAL, PANGASINAN AMOUNTING TO THIRTEEN MILLION THIRTY-FIVE THOUSAND FOUR HUNDRED FIFTY-ONE & 34/100 PESOS (P13,035,451.34)”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Municipal Resolution No. 2024-190 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Municipal Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 3 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on July 24, 2024 by the Municipal Development Council through Resolution No. 6, Series of 2024, and was favorably acted upon by the Sangguniang Bayan on September 2, 2024 through Resolution No. 2024-190;
2. The SIP No. 2 of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses of some municipal government offices of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP13,035,451.34 is embodied in their proposed Supplemental Budget No. 03 CY 2024 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04 CY 2024 on September 2, 2024.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;


