RESOLUTION NO. 63-2025

DECLARING MUNICIPAL ORDINANCE NO. 203-230924 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "E-CIGARETTES REGULATION ORDINANCE OF THE MUNICIPALITY OF VILLASIS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 203-230924 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 and 447 (a) (1) (iii) (3) & (ii) of R.A. No. 7160; DILG Memorandum Circular No. 2017-147 dated November 3, 2017; Section 24 of the Republic Act No. 8749, otherwise known as the "Philippine Clean Air Act of 1999" and Section 5 of the Republic Act No. 9211, or the "Tobacco Regulation Act of 2003";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 203-230924 of the Sangguniang Bayan of Villasis, Pangasinan, entitled "E-Cigarettes Regulation Ordinance of the Municipality of Villasis, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
