### PROVINCIAL RESOLUTION NO. 70-2025

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH ILOCOS CENTER FOR HEALTH DEVELOPMENT I PERTAINING TO THE ENHANCEMENT OF THE ISOLATION AND LABORATORY FACILITIES AT THE PANGASINAN PROVINCIAL HOSPITAL**

**WHEREAS**, the Department of Health (DOH) is the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities and has manifested its desire to further augment its support to the Provincial Government of Pangasinan's health care program;

**WHEREAS**, as part of its aim to strengthen the country's capacity to prevent, detect and respond to the threat posed by COVID-19, the Department of Health established the Philippines COVID-19 Emergency Response Project (PCERP) which aims to strengthen national systems for public health preparedness through the establishment of isolation and quarantine facilities;

**WHEREAS**, the Province of Pangasinan, through the Pangasinan Provincial Hospital, will be the recipient of goods and civil works under the aforesaid Project from the Department of Health Ilocos Center for Health Development I in the form of a donation pertaining to the Upgrading of Isolation and Laboratory Facilities with contract amount of P9,410,442.37;

**WHEREAS**, the Province of Pangasinan expresses its willingness to accept the said donation as this will further improve the isolation and laboratory capacity of the Pangasinan Provincial Hospital through its prevention, preparedness, and response to emerging infectious diseases;

**WHEREAS**, it is necessary that a Deed of Donation be executed by both Parties to fully implement the said project as well as to ensure proper documentation of such transfer of property;

**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to sign the Deed of Donation and accept the goods and civil works from the Department of Health Ilocos Center for Health Development I to further intensify the need for the implementation of health programs and services to the people of Pangasinan;

**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

**WHEREAS**, for the above purpose, the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Department of Health Ilocos Center for Health Development I, represented by Dr. Paula Paz M. Sydiongco, Regional Director, shall enter into and sign a Deed of Donation;

**NOW, THEREFORE**, on motion of SP Members Shiela Marie F. Baniqued and Jerry Agerico B. Rosario, duly seconded, it was –


**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Deed of Donation with the Department of Health Ilocos Center for Health Development I pertaining to the enhancement of the isolation and laboratory facilities at the Pangasinan Provincial Hospital;
