INTERPOSING NO OBJECTION TO THE IMPLEMENTATION OF THE SAN ROQUE OPTIMIZATION PROJECT OF SAN ROQUE HYDROPOWER, INC. (SRHI) LOCATED IN THE MUNICIPALITIES OF SAN NICOLAS AND SAN MANUEL, PROVINCE OF PANGASINAN, AND ENDORSING THE SAME TO THE DEPARTMENT OF ENERGY

WHEREAS, San Roque Hydropower Inc., formerly known as Strategic Power Development Corporation and a subsidiary of San Miguel Global Power Holdings Corp., has applied for and proposed to develop the San Roque Optimization Project at its identified project site located in the Municipalities of San Nicolas and San Manuel, Province of Pangasinan;

WHEREAS, San Roque Hydropower Inc., in its letter dated December 26, 2024, has requested the Provincial Governor, Ramon V. Guico III, for a resolution of support and no objection to the aforesaid proposed project;

WHEREAS, San Roque Hydropower Inc. has already presented to the Sangguniang Panlalawigan the purpose of the project during its Regular Session held on January 13, 2025 and provided information in order to accelerate the energy program in the area apart from the socio-economic and environmental benefits that Pangasinan as host province will enjoy;


