PROVINCIAL RESOLUTION NO. 78-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE FOUNDATION FOR PHILIPPINE MEDICAL MISSIONS (FPM) AND THE JUNIOR CHAMBER INTERNATIONAL – HUNDRED ISLANDS (JCIH) FOR THE CONDUCT OF 2025 ALAGANG PAMILYA MEGA MEDICAL MISSION IN ALAMINOS CITY, PANGASINAN ON FEBRUARY 23-28, 2025

WHEREAS, the Foundation for Philippine Medical Missions is a non-profit and all-volunteer organization of healthcare professionals based and founded in the Twin Cities in Minnesota, USA, with its mission to provide free medical services to the different parts of the country;

WHEREAS, the Junior Chamber International – Hundred Islands is an organization of young and concerned citizens aged 18-40 who are actively participating and engaging in all notable programs and projects of JCI;

WHEREAS, the Provincial Government of Pangasinan, through the Western Pangasinan District Hospital, in collaboration with the Foundation for Philippine Medical Missions and the Junior Chamber International – Hundred Islands, will join efforts in conducting a six-day medical mission on February 23-28, 2025;

WHEREAS, a Memorandum of Understanding is necessary to define the duties and responsibilities of the concerned parties for the conduct of the medical, surgical, optical and dental mission;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign the Memorandum of Understanding to further augment the need for free medical services not only to the people of Alaminos City, Pangasinan, but also other neighboring municipalities of the western parts of Pangasinan;
