RESOLUTION NO. 84-2025

APPROVING RESOLUTION NO. 182-2024 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 3 FOR FISCAL YEAR 2024 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 182-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Urbiztondo, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 3 for CY 2024. This was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 05, S-2024 dated November 27, 2024. This is in accordance with Sections 106, 109, and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱2,843,620.60, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices of the LGU, and implementation of LDRRM programs and other priority projects of the municipality; and




