RESOLUTION NO. 88-2025

**DECLARING THE SUPPLEMENTAL BUDGET NO. 8 FOR
CALENDAR YEAR 2024 OF BAYAMBANG, PANGASINAN,
INVOLVING A TOTAL APPROPRIATION OF P80,000,000.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Supplemental Budget No. 8 for Calendar Year 2024 involving total appropriations of P80,000,000.00, which was enacted on December 2, 2024 through Appropriation Ordinance No. 10, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the total fund source available for supplemental appropriation (i.e. Proceeds from Loan from the Land Bank of the Philippines (LBP) will be made actually available as required under Article 417(a) of the IRR of R.A. No. 7160, as amended by Administrative Order No. 47 April 12, 1993, and as contained in the Omnibus Term Loan Agreement between the LBP and the municipality of Bayambang;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its Supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007, dated 08 March 2007;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
4. That the additional utilization of all appropriations for Capital Outlay, shall, as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as rules by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing, et al vs. Hon. Gwendolyn F. Garcia, et al., G.R. No. 175527, December 8, 2008.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Member Shiela Marie F. Baniqued and Vici M. Ventenilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


