APPROVING RESOLUTION NO. 333, S-2024 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR CY 2024 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 333, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Binmaley, Pangasinan prepared their Supplemental Investment Program (SIP) No. 4 for CY 2024. This was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 5, Series of 2024, dated October 3, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has a total investment requirement of ₱24,413,199.92, covers the augmentation of funds for Capital Outlay of the LGU, and implementation of DRRM and development projects of the municipality;

3. The project proposed to be funded from the 5% LDRRM Fund is based on the Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the of the Local Disaster Risk Reduction and Management Fund). Likewise, the projects proposed to be funded from the 20% Development Fund conform with Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
4. Funding support for the implementation of the SIP is embodied in their Supplemental Budget No. 3 for FY 2024, which was enacted by the LGU's Sangguniang Bayan through Appropriation Ordinance No. 3, Series of 2024, dated October 28, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


