**RESOLUTION NO. 95-2025**

**DECLARING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF SAN NICOLAS, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P1,344,740.40, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P1,344,740.40, which was enacted on October 15, 2024 through Appropriation Ordinance No. 3, Series of 2024;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No 7160 (Use of Appropriated Funds and Savings).


