APPROVING MUNICIPAL RESOLUTION NO. 315, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 5 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Resolution No. 315, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Nicolas, Pangasinan has identified items in their Supplemental Annual Investment Program No. 5 for CY 2024. This was endorsed by the MDC Executive Committee to the Sangguniang Bayan on October 21, 2024 through MDC Resolution No. 08, CY-2024;
- The SAIP No. 5 of the municipality covers fund augmentation for Maintenance and Other Operating Expenses of the LGU San Nicolas; and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP2,017,956.10 is embodied in the municipality's Supplemental Budget No. 5-CY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05, Series of 2024 on November 26, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
