RESOLUTION NO. 123-2025

APPROVING RESOLUTION NO. 102, S-2024 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03, CY-2024 OF THE LOCAL GOVERNMENT UNIT, DASOL, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 102, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Dasol, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 03 CY 2024. This was endorsed to the Sangguniang Bayan on December 9, 2024 through MDC ExeCom Resolution No. 4, Series of 2024 and was favorably acted upon by the Sangguniang Bayan on December 10, 2024 through SB Resolution No. 102, S-2024;
2. Said SAIP covers fund augmentation for Personal Services (granting of Service Recognition Incentive to qualified municipal officials and employees, and other personnel benefits) and Maintenance and Other Operating Expenses of various municipal government offices, and the implementation of disaster risk reduction management program and other priority programs/projects of the LGU;

3. Funding support for the proposed SAIP, with a total investment requirement of Php5,684,761.29, is embodied in the municipality's Supplemental Budget No. 3 CY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 188 on December 10, 2024 and approved by the Municipal Mayor on December 16, 2024.


