RESOLUTION NO. 134-2025

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2025 OF BASISTA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P189,199,179.13, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Annual Budget for Calendar Year 2025 involving total appropriations of P189,199,179.13, which was enacted on October 28, 2024 through Appropriation Ordinance No. 3, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the appropriation for the implementation of the First Tranche Salary Schedule for Local Government Personnel pursuant to Executive Order No. 64, S.2024 shall be subject to the provisions of Local Budget Circular No. 160 of the Department of Budget & Management August 12, 2024, specifically Item No. 5.0 thereof;
- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the 2025 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memo Circular No. 1, Series of 2007 dated March 8, 2007;

- 3. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020;
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
- 5. That the Hazard Pay for health workers shall be subject to the provisions of R.A. No. 7305 (Magna Carta of Public Health Workers);
- 6. That the disbursement of Magna Carta Benefits of Public Social Workers shall be in accordance with DBM-DSWD Joint Circular No. 1, S.2018 dated December 27, 2018 re: Rules & Regulations on the Grant of Compensation-Related Magna Carta Benefits to Public Social Workers (PSWs);
- 7. That the appropriation of Consultancy Services shall be used strictly for the professional service fees of consultants/experts who will provide highly specialized or technical expertise that cannot be provided by the regular staff of Municipal Government;
- 8. That the utilization of all appropriation for Capital Outlay, shall as may be applicable, be subject to authorization of the Sangguniang on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing et. al vs. Hon. Gwendolyn f. Garcia, et.al G.R 1755-22, December 8, 2008;
- 9. That the appropriation for the payment of Terminal Leave Benefits (TLB) and monetization of leave credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
- 10.That the appropriation for Election Reserve shall be in accordance to COMELEC Resolution No. 1099 dated May 24, 2024 with the subject: "Calendar of Activities and Periods of Certain Prohibited Acts in Connection with the May 12, 2025 National and Local Elections (NLE) and BARMM Parliamentary Elections";

- 11. That the items funded out of the Local Disaster Risk Reduction & Management Fund shall be in accordance with R.A No. 10121 known as the Philippine Disaster Risk Reduction & Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation & Utilization of the Local Disaster Risk Reduction & Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund;
- 12. That the grant of step increment to municipal employees and elective officials shall be in accordance with CSC-DBM Joint Circular No. 01, S. 2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S. 2016 dated January 27, 2026; and
- 13. That the excess in PS shall be subject to Sec. 325(a) of R.A. 7160, hence, filling up of vacant positions except for mandatory positions shall not be allowed.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Annual Budget for Calendar Year 2025 of Basista, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Basista, Pangasinan, for its information and guidance.
