#### **RESOLUTION NO. 138-2025**

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF LINGAYEN, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P24,193,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P24,193,000.00, which was enacted on December 11, 2024 through Appropriation Ordinance No. 03, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

- 3. That the appropriation for Monetization of Leave Credits shall be subject to the provision of DBM Budget Circular No. 2016-2 dated March 29, 2016 Re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
- 4. That the grant of Other Personnel Benefits Service Recognition Incentive (SRI) to government employees for Fiscal Year 2024 shall be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024 by the Department of Budget and Management;
- 5. That the grant of Other Personnel Benefits Collective Negotiation Agreement (CNA) Incentive for FY 2024 to government employees shall be in accordance with the provisions of Budget Circular No. 2024-4 dated November 11, 2024 of the Department of Budget and Management;
- 6. That the grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for FY 2024 shall be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024 of the Department of Budget and Management;
- 7. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
- 8. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017 dated March 8, 2007;
- 9. That the appropriation and utilization for Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and that 30% shall be set aside as Quick Response Fund; and
- 10. That the utilization of appropriation from 20% of the Annual National Tax Allotment (NTA) for development projects (20% Development Fund) shall be subject to the provisions of DILG-DBM Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation and Utilization of Twenty Percent (20%) of the Annual Internal Revenue Allotment for Development Projects.
