RESOLUTION NO. 141-2025

APPROVING SB RESOLUTION NO. 177-2024 OF THE SANGGUNANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 3RD SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Resolution No. 177-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality’s 3rd Supplemental Investment Program for CY 2024. This was endorsed by the Council, through MDC Resolution No. 03, Series of 2024 dated August 19, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program (SIP), which has an investment requirement of ₱16,898,024.40, covers the augmentation of funds for Personal Services (Implementation of the First Tranche of the Modified Salary Schedule for LGU Personnel) and Maintenance and Other Operating Expenses (MOOE) of some municipal offices of the LGU, and implementation of LDRRM programs and priority projects of the municipality; and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2024 dated October 1, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Manaoag, Pangasinan;


