**RESOLUTION NO. 142-2025**

**DECLARING SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR  
YEAR 2024 OF MANAOAG, PANGASINAN, INVOLVING A TOTAL  
APPROPRIATION OF P16,898,024.40, OPERATIVE IN ITS  
ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P16,898,024.40, which was enacted on October 1, 2024 through Appropriation Ordinance No. 03, Series of 2024;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

3. That all procurements to be undertaken shall be subject to the provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the grant of the First Tranche salary adjustment to all municipal officials and employees shall be implemented in accordance to the issued Local Budget Circular Number 160 by the Department of Budget and Management dated August 12, 2024, specifically Item 5.0 thereof;
5. That the appropriation for the employer (government) share in the premium contributions to the Philippine Health Insurance Corporation (PhilHealth) shall be in accordance to PhilHealth Circular Letter No. 2019-0009 dated October 25, 2019;
6. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund;
7. That the appropriation of Other Personnel Benefits and Service Recognition Incentive (SRI) shall only be disbursed upon issuance of circular granting the same, otherwise, the same are bereft of legal basis; and
8. That the appropriation for Monetization of Leave Credits shall be subject to the provision of DBM Budget Circular No. 2016-2 dated March 29, 2016 Re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 3 for Calendar Year 2024 of Manaoag, Pangasinan;


