RESOLUTION NO. 145-2025

DECLARING MUNICIPAL ORDINANCE NO. 2024-05 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2018-07, "ESTABLISHING THE UNIVERSITY OF EASTERN PANGASINAN IN THE MUNICIPALITY OF BINALONAN, PANGASINAN AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Ordinance No. 2024-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the legislative body to enact and approve ordinances or resolutions carries with it the power to amend, revoke, modify or repeal the same";

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2024-05 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled "An Ordinance amending Municipal Ordinance No. 2018-07, "Establishing the University of Eastern Pangasinan in the Municipality of Binalonan, Pangasinan and for Other Purposes" as within the conferred powers of the Sangguniang Bayan to enact;
