APPROVING RESOLUTION NO. 24-154 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 003 SERIES OF 2024 EMBODYING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR FY 2024 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 24-154 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sta. Maria, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 02 for FY 2024. This was endorsed to the Sangguniang Bayan on December 4, 2024 through MDC Resolution No. 003, Series of 2024;
2. The SIP No. 02 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive and other Personnel Benefits to qualified municipal officials and employees) and Maintenance and Other Operating Expense of some municipal offices and the implementation of disaster risk reduction programs and other development projects of the municipality;

3. Likewise, SIP No. 02 also covers the implementation of programs, projects and activities (Construction of Post-Harvest Facility in Brgys. San Vicente and Samon) to be funded from the municipality's share from the FY 2022 Burley and Native Tobacco Excise Tax Collection. Said project is consistent with Local Budget Memorandum No. 91 dated August 29, 2024; and
4. Funding support for the proposed SIP No.02, with a total investment requirement of PhP4,700,717.40 is embodied in the municipality's Supplemental Budget No. 2, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 24-06 on December 12, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Maria, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


