**WHEREAS**, the Sangguniang Panlalawigan of Pangasinan approved Provincial Ordinance No. 315-2024, entitled “An Ordinance Institutionalizing the Organization, Establishment, and Operation of the Provincial Learning and Development Institute (PLDI)”, to extend carefully crafted training programs to HR practitioners, leaders, and learners from across various organizations;


**RESOLVED, FURTHER**, that the necessary actions and processes be undertaken to effect the change in signage, official documents, and other relevant materials to reflect the new name;
