RESOLUTION NO. 197-2025

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2025 OF ANDA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P222,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Annual Budget for Calendar Year 2025 involving total appropriations of P222,000,000.00, which was enacted on November 21, 2024 through Appropriation Ordinance No. 05, Series of 2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the implementation of the Second Tranche salary adjustment to all municipal officials and employees shall be subject to the provisions of Executive Order No. 64 of the Office of the President dated August 2, 2024 and the specific guidelines for Local Government Units to be issued by the Department of Budget and Management;

2. That the projects under the 20% of the Annual National Tax Allotment (NTA) for development projects (20% Development Fund) shall be subject to the provisions of DILG-DOF-DBM Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020. Re: Revised Guidelines on the Appropriation and Utilization of Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;
3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
4. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121, known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund;
5. That the grant of step increment to some municipal employees and elective officials shall be in accordance with the CSC-DBM Joint Circular No. 01, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The appropriation for salaries of the following should therefore be adjusted as follows:

6. That the disbursement of appropriation for Terminal Leave Benefits shall be subject to the provisions of DBM Budget Circular No. 2016-02 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave credits, which provides for the new constant factor stated under Item 3.1;
7. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
8. That the Magna Carta Benefits of Public Health Workers shall be subject to the provisions of R.A. No. 7305 & DBM-DOH Joint Memorandum Circular No. 1, S. 2018 dated November 29, 2018 re: Rules & Regulations on the Grant of Compensation Related Magna Carta Benefits to Public Health Workers (PHWs);
9. That the appropriation for Other Personnel Benefits to all qualified officials and employees of the municipality shall only be disbursed pursuant to the specific guidelines granting the same to be issued by proper authority;
10. That the Representation and Transportation Allowances (RATA) of the Municipal Government Department Head I (MDRRMO) shall be adjusted to P14,450.00 per month pursuant to Local Budget Circular No. 157 dated May 3, 2024 of the Department of Budget and Management;
11. That the excess in appropriation for Cash Gift under the Office of the Mayor, Municipal Vice Mayor and the Office of the Sangguniang Bayan shall not be allowed; and
12. That the effect of the Final 2025 NTA shares of LGUs will necessitate prioritization in the implementation of items of appropriations by the LGU.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Annual Budget for Calendar Year 2025 of Anda, Pangasinan;




