RESOLUTION NO. 199-2025

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2025 OF BOLINAO, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P434,792,774.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Annual Budget for Calendar Year 2025 involving total appropriations of P434,792,774.00, which was enacted on November 7, 2024 through Appropriation Ordinance No. 2024-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the implementation of the Second Tranche salary adjustment to all municipal officials and employees shall be subject to the provisions of Executive Order No. 64 of the Office of the President dated August 2, 2014 and the specific guidelines for LGUs to be issued by Department of Budget and Management (DBM). Provided further that the same be implemented not earlier from the date of the approval of the Appropriation Ordinance authorizing the supplemental budget for the implementation of the first tranche salary adjustment;

- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
- 3. That the projects funded under 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No.1 dated November 4, 2020;
- 4. That the items funded out of the 5% Local Disaster Risk Reduction & Management Fund shall be in accordance with R.A. No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular no. 2013-1 dated March 25, 2013 re: Allocation & Utilization of the Local Disaster Risk Reduction and management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund;
- That all procurements to be undertaken shall be in accordance with the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act.) and its revised Implementing Rules and Regulations;
- 6. That the appropriation for the employer (government) share in the premium contributions to the Philippine Health Insurance Corporation (PhilHealth) shall be in accordance to PhilHealth Circular Letter No. 2019-0009 dated October 25, 2019;
- 7. That the appropriation of Other Personnel Benefits to qualified government employees shall be in accordance with the specific guidelines authorizing the same;
- 8. That the Appropriation for Terminal Leave and Monetization of Leave Credits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016, Re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
- That the disbursement of Magna Carta Benefits of Public Health Workers shall be in accordance with DBM-DOH Joint Memorandum Circular No.1, s. 2012 dated November 29, 2012, Re: Rules and Regulations on the Grant of Compensation- Related to Magna Carta Benefits to Public Health Workers (PHWs);

- 10. That the disbursement of Magna Carta Benefit of Public Social Workers shall be in accordance with DBM-DSWD Joint Circular No.1, S. 2018 dated December 27, 2018, Re: Rules and Regulations on the Grant of Compensation- Related Magna Carta Benefits to Public Social Workers (PSWs);
- 11. That the effect of the Fiscal Year 2025 Final National Tax Allotment (FNTA) shares of the LGU necessitate the prioritization in the implementation of items of appropriations by the LGU;
- 12. That the appropriation for Service Recognition Incentive (SRI) for C.Y. 2025 of municipal officials and employees shall be disbursed upon the issuance of a circular granting the same to be issued by proper authorities and shall be subject to Section 325 (a) of R.A. 7160; and
- 13. That the appropriation and disbursement of Election Reserve shall be in accordance with COMELEC Resolution No.1099 promulgated on May 12, 2024.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Annual Budget for Calendar Year 2025 of Bolinao, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bolinao, Pangasinan, for its information and guidance.
