RESOLUTION NO. 200-2025

APPROVING RESOLUTION NO. 446, S-2024 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 FOR CY 2024 OF BASISTA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 446, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 4 for CY 2024 and endorsed the same through MDC Resolution No. 5, Series of 2024 dated December 14, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental Investment Program, which has a total investment requirement of ₱1,456,093.41, covers the augmentation of funds for Personal Services (Implementation of the First Tranche of Salary Increase for LGU officials and employees and other personnel benefits) Maintenance and other Operating Expenses and Capital Outlay of the LGU; and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 4, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 5, Series of 2024 dated December 16, 2024 and approved by the Local Chief Executive on December 18, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Basista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
