APPROVING RESOLUTION NO. 397, S-2024 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 10 WITH THE CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 9 (GRATUITY PAY) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 397, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Asingan, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 9 for CY 2024. This was endorsed to the Sangguniang Bayan on December 23, 2024 through MDC Resolution No. 10, S-2024;
- 2. The SAIP No. 9 of the municipality covers fund augmentation for Personal Services (Granting of Gratuity Pay to Qualified Officials and Employees of LGU Asingan); and

3. Funding support for the proposed SAIP, with a total investment requirement of PhP1,386,000.00 is embodied in the municipality's Supplemental Budget No. 7 which were approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 9, Series of 2024 on December 23, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;
