**APPROVING RESOLUTION NO. 2024-284 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 06 OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO NINE MILLION FOUR HUNDRED NINETEEN THOUSAND SEVENTY-FOUR PESOS AND TWENTY-FIVE CENTAVOS (P9,419,074.25)"**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2024-284 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan had identified items in their CY 2024 Supplemental Annual Investment Program (SAIP) No. 06. This was endorsed to the Sangguniang Panlungsod for approval on December 5, 2024 by the City Development Council Executive Committee through Resolution No. 2024-09, Series of 2024;
2. Said SAIP covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses of some city government offices of the LGU;

3. Funding support for the implementation of the same in the amount of PhP9,419,074.25 is embodied in their proposed Supplemental Budget No. 05 for CY 2024 which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 2024-06 on December 17, 2024.


