RESOLUTION NO. 243-2025

DECLARING ORDINANCE NO. 2024-23 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS CITY, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION PROGRAM IN THE CITY OF ALAMINOS, PANGASINAN, AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-23 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said city ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iii) and (iv) & 458 (a) (5) (xiv) of R. A. No. 7160; Memorandum Circular No. 02, Series of 2014 by the Department of Social Welfare and Development, entitled “Guidelines to Strengthen and Enhance the Implementation of the Assistance to Individuals in Crisis Situations (IACS)”;

Memorandum Circular No. 11, Series of 2019 or the “Revised Guidelines on the Implementation of Assistance to Individuals in Crisis Situation”;

WHEREAS, it is now incumbent on the part of the Local Government Unit to include the PPAs in its Gender and Development Plan and provide the said appropriation to implement the subject Ordinance;


