**APPROVING RESOLUTION NO. 2024-251 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5 CY 2024 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2024-251 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Mangaldan, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 5, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 9, Series of 2024 dated December 6, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has an investment requirement of P11,902,238.00, covers the augmentation of funds for Personnel Services, Maintenance and Other Operating Expenses and Capital Outlay of some offices of the LGU, and implementation of DRRM program and agricultural projects supportive to tobacco farmers of the municipality;

3. The project, “Provision of Production Support for Tobacco Farmers” to be funded from the LGU Share from the Excise Tax (CY 2022), in the amount of P212,607.00 is based on Local Budget Memorandum No. 91 of the Department of Budget and Management; and
4. Funding for the Supplemental AIP is embodied in the LGU’s Supplemental Budget No. 5, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-06 dated December 12, 2024 and approved by the Municipal Mayor on December 1, 2024.


