RESOLUTION NO. 289-2025

APPROVING SB RESOLUTION NO. 269-2024 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 02 FY 2024 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Resolution No. 269-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Mangatarem, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for FY 2024. This was endorsed by the Council, through MDC ExeCom Resolution No. 03, Series of 2024 and approved the Sangguniang Bayan on December 19, 2024. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The Supplemental Investment Program, which has a total investment requirement of ₱13,626,134.20, covers the augmentation of funds for Personal Services (Granting of Service Recognition Incentive and Collective Negotiation Agreement Incentive to Qualified Municipal Employees), Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of development projects and other priority programs of the Municipal Government;

- 3. The projects proposed to be funded from the realignment of 20% Development Fund, are based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects); and
- 4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 02, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2024 dated December 19, 2024 and approved by the Municipal Mayor on December 26, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 269-2024 of the Sangguniang Bayan of Mangatarem, Pangasinan, entitled "Approving the Supplemental Investment Program No. 02 FY 2024 of the Municipality of Mangatarem, Pangasinan";
