RESOLUTION NO. 294-2025

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR
CALENDAR YEAR 2024 OF SAN JACINTO, PANGASINAN,
INVOLVING A TOTAL APPROPRIATION OF P14,592,076.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P14,592,076.00, which was enacted on December 23, 2024 through Appropriation Ordinance No. 2024-04, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;

3. That the utilization of appropriations from shares from the FY 2022 Collections of Excise Tax on Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351 shall be subject to the provisions of Local Budget Memorandum No. 91 dated August 29, 2024;
4. That the appropriation of Other Personnel Benefits - Service Recognition Incentive (SRI) shall be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024;
5. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121, known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: *Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF)*, and that 30% shall be set aside as Quick Response Fund; and
6. That the grant of Gratuity Pay for FY 2024 of the municipality shall be in accordance with the provisions of Budget Circular No. 2024-8 dated December 20, 2024.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 3 for Calendar Year 2024 of San Jacinto, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of San Jacinto, Pangasinan, for its information and guidance.
