RESOLUTION NO. 297-2025

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2024 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING REPUBLIC ACT NO. 9482, OTHERWISE KNOWN AS THE ANTI-RABIES ACT OF 2007, AND PROVIDING GUIDELINES FOR ITS EFFECTIVE IMPLEMENTATION IN THE MUNICIPALITY OF SANTO TOMAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Municipal Ordinance No. 02, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 447 (4) of R.A. No. 7160, R.A. 8485 or "The Animal Welfare Act of 1998", R.A. No. 9482 or "The Anti-Rabies Act of 2007";

WHEREAS, subject ordinance shall take affect after compliance with the requirement of publication pursuant to Section 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
