#### **RESOLUTION NO. 305-2025**

APPROVING RESOLUTION NO. 24-169(b) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 10 FOR CALENDAR YEAR 2024 OF THE CITY GOVERNMENT OF SAN CARLOS PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 24-169(b) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

- 1. The City Development Council of San Carlos City, Pangasinan prepared the LGU's Supplemental Investment Program No. 10, CY 2024. This was endorsed by the Council, through CDC ExeCom Resolution No. 12-24 (Series of 2024) dated September 12, 2024 to the Sangguniang Panlungsod for approval. This is in accordance in accordance with Sections 106, 109 and 114 of the Local Government of 1991;
- 2. The Supplemental Investment Program (SIP), which has a total investment requirement of P32,250,000.00, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU, and implementation of infrastructure and other priority projects of the City Government; and

3. Funding support for the implementation of the SIP is embodied in the LGU's Supplemental Budget No. 09-24, FY 2024, which was enacted by their Sangguniang Panlungsod through Appropriation Ordinance No. 24-18(a) dated September 30, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos, Pangasinan;
