APPROVING RESOLUTION NO. 2024-455 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2024-07 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2024, REQUIRING A TOTAL FUNDING OF TWENTY TWO MILLION NINE HUNDRED SIXTY SIX THOUSAND SEVEN HUNDRED FORTY NINE PESOS (P22,966,749.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2024-455 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2024-07, CY 2024. This was endorsed by the Council, through MDC Resolution No. 2024-17, Series of 2024 dated December 16, 2024, to the Sangguniang Bayan for approval. 2. Said Supplemental AIP, which has a total investment requirement of ₱22,966,749.00, covers fund augmentation for Personal Services (granting of Service Recognition Incentives for LGU Personnel and implementation of projects supportive to tobacco farmers and DRRM program of the LGU;
3. The projects proposed to be funded from the Tobacco Excise Tax Share of the LGU (CY 2022) conform with Local Budget Memorandum No. 9, dated August 29, 2024 of the Department of Budget and Management; and
4. Funding Support for the full implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 06, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-055, Series of 2024 dated December 19, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipality of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


