RESOLUTION NO. 311-2025

DECLARING MUNICIPAL ORDINANCE NO. 04, S-2024 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “AN ORDINANCE DECLARING OCTOBER 10 OF EVERY YEAR AS THE MENTAL HEALTH DAY IN THE MUNICIPALITY OF SAN FABIAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 04, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 11036, entitled: “An Act Establishing a National Mental Health Policy for the Purpose of Enhancing the Delivery of Integrated Mental Health Services, Promoting and Protecting the Rights of Persons Utilizing Psychiatric, Neurologic and Psychosocial Health Services, Appropriating Funds Therefore and for Other Purposes, Section 15 of R.A. No. 11036 and Section 16 of R.A. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 04, S-2024, of the Sangguniang Bayan of San Fabian, Pangasinan, entitled “An Ordinance declaring October 10 of every year as the Mental Health Day in the Municipality of San Fabian, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;


