#### **RESOLUTION NO. 314-2025**

**OF** THE 150-S-2024 APPROVING RESOLUTION NO. SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL OF THE LOCAL INVESTMENT PLAN NO. 6, CY-2024 **PANGASINAN OF** SAN FABIAN, GOVERNMENT UNIT AMOUNTING TO PHP3,611,853.12 FROM THE REALIGNMENT OF VARIOUS FUNDS"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 150, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 6 for CY 2024. This was endorsed by the Council, through MDC Executive Committee Resolution No. 09-S.2024 dated December 18, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has an investment requirement of \$\mathbb{P}\_{3},611,853.12\$, covers fund augmentation for Personal Services of some offices of the LGU, and implementation of development projects of the municipality;

The project proposed to be funded from the reprogramming of a project from the 20% Development Fund (CY 2024), in the amount of ₽700,000.00 is based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects); and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 6 for CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 7, S-2024 dated December 19, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 150, S-2024 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled "Approving the Supplemental Annual Investment Plan No. 6, CY-2024 of the Local Government Unit of San Fabian, Pangasinan amounting to Php3,611,853.12 from the realignment of various funds";
