PROVINCIAL RESOLUTION NO. 342-2025

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HOME DEVELOPMENT MUTUAL FUND (HDMF) OR PAG-IBIG FUND FOR THE IMPLEMENTATION OF THE PAG-IBIG MEMBERSHIP COVERAGE PROGRAM OF JOB ORDER (JO) AND CONTRACT OF SERVICE (COS) WORKERS OF THE PROVINCE OF PANGASINAN

WHEREAS, pursuant to Section 2 of Republic Act No. 9679 or the “Home Development Mutual Fund (HDMF) Law of 2009”, HDMF or Pag-Ibig Fund is mandated to improve the quality of life of its members by developing and promoting an integrated nationwide mutual provident savings system suitable for the needs of the employed and other earning groups;

WHEREAS, the HDMF or Pag-Ibig Fund has launched the Pag-IBIG Membership Coverage Program which aims to provide accessible and affordable housing programs and services for the Pangasinenses;

WHEREAS, one of the identified beneficiaries of said Program are Job Order (JO) and Contract of Service (COS) workers who are considered self-employed individuals and mandatorily covered under Section 1 (a)(4), Rule 5 of the Implementing Rules and Regulations of RA 9679;

WHEREAS, in recognition of the value of the work of JO and COS workers engaged by the Provincial Government of Pangasinan, the latter, in partnership with Pag-IBIG Fund, has signified its willingness and commitment to implement the mandatory membership coverage of JO and COS workers under Republic Act 9679;

WHEREAS, this Pag-IBIG Membership Coverage Program shall greatly benefit said employees of the Provincial Government of Pangasinan through a more efficient and convenient means to avail of Pag-Ibig housing loan program;
