**PROVINCIAL RESOLUTION NO. 343-2025**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE DEED OF DONATION AND RECEIVE/ACCEPT CASH DONATION FROM THE IXUS SOLAR ENERGY CORP.**

**WHEREAS**, the IXUS Solar Energy Corp. is a registered renewable energy developer undertaking the development of a 550MW solar plant located in the Municipality of Bugallon in the Province of Pangasinan;

**WHEREAS**, as part of the mandate of its corporate social responsibility, the IXUS Solar Energy Corp. desires to help the Province to uplift the socio-economic conditions of communities within its jurisdiction by providing financial assistance;

**WHEREAS**, the IXUS Solar Energy Corp. intends to transfer and convey, unto the Province of Pangasinan, the amount of Fifteen Million Pesos (P15,000,000.00), by way of Donation;

**NOW, THEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was -


