PROVINCIAL RESOLUTION NO. 344-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A SUPPLEMENTAL MEMORANDUM OF AGREEMENT (MOA) WITH EXAKT MEDICAL SERVICES CORPORATION FOR THE IMPLEMENTATION OF AN INTEGRATED HEALTH DELIVERY SOLUTION FOR THE PROVINCIAL GOVERNMENT OF PANGASINAN AS ELECTRONIC MEDICAL RECORDS (EMR) PROVIDER FOR THE SECOND TRANCHE

WHEREAS, RA 11223 or the Universal Health Care Act of 2019 mandates the implementation of health reform program which ensures that every Filipino is guaranteed an equitable access to quality and affordable healthcare services and is protected against financial risks;

WHEREAS, the law mandates that local health systems shall have a primary care provider network with patient records accessible throughout the health system;

WHEREAS, the Philippine Health Insurance Corporation is the agency mandated to implement the Universal Health Care Act to provide all Filipinos access to a primary care provider that will deliver basic essential services at every life stage that aims to promote health, identify risk, and ensure early diagnosis, treatment and care through the Philhealth Konsultasyong Sulit at Tama (Philhealth Konsulta) Program;

WHEREAS, the Province of Pangasinan has established the Pangasinan Government Unified Incentives for Medical Consultation Program dubbed as "GuiKonsulta" in pursuance to the provisions of the Universal Health Care Act and Philhealth Konsulta with the aim to promote preventive health care for every Pangasinense especially the underprivileged;

WHEREAS, the Provincial Government of Pangasinan has already engaged the services of Exakt Medical Services Corporation as a Solution Provider through a previous Memorandum of Agreement (MOA) entered into by the Province and the latter to provide technological solutions and manpower to assist the Province in its objective to implement the program using medical and technology products, electronic medical records and electronic claims system;

WHEREAS, the Philhealth Konsulta Program covers two (2) tranches and the First Tranche which concerns the payment for the First Patient Encounter or Registration has already been included in the previous MOA with Exakt Medical Services Corporation;

WHEREAS, the Exakt Medical Services Corporation has offered to include its services as an Electronic Medical Records (EMR) for the Second Tranche which entails the payment for the Second Patient Encounter for Consultation, Diagnostics, and Medications, and which the Province has accepted;

WHEREAS, for the above purpose, a Supplemental Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and Exakt Medical Services Corporation, represented by Ms. Michelle Francesca Nicole H. Groves, President;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

NOW, THEREFORE, on motion of SP Members Sheila Marie F. Baniqued and Napoleon C. Fontelera, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Supplemental Memorandum of Agreement with Exakt Medical Services Corporation for the implementation of an integrated health delivery solution for the Provincial Government of Pangasinan as Electronic Medical Records (EMR) provider for the Second Tranche;






