**PROVINCIAL RESOLUTION NO. 345-2025**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO SIGN A DEED OF DONATION AND ACCEPT A 3,000-SQUARE METER LOT COVERED BY CERTIFICATE OF TITLE NO. 026-2020000427 IN ALCALA, PANGASINAN TO BE USED FOR THE ESTABLISHMENT OF A GOVERNMENT HOSPITAL**

**WHEREAS**, the Municipality of Alcala, Pangasinan, represented by Mayor Jojo B. Callejo, purchased an unsegregated portion of 4,000 square meters from the 32,629 square meters parcel of land owned by the Roman Catholic Bishop of Urdaneta, Inc., annotated in the Memorandum of Encumbrance of the Transfer Certificate of Title No. 026-2020000427, with Entry No. 2024004804;

**WHEREAS**, the subject parcel of land is registered in the name of the Municipality of Alcala, Pangasinan, represented by Mayor Jojo B. Callejo, and is declared under Tax Declaration No. 03-0001-00725 with Property Identification No. 013-40-0001-005-33-B-2 situated in Barangay Poblacion East, Alcala, Pangasinan;

**WHEREAS**, one of the primordial concerns of the Provincial Government of Pangasinan is to improve and upgrade health facilities in order to sufficiently provide emergency and primary health care services to the people;

**WHEREAS**, in consonance with the vision and mission on health programs of the present administration, the Municipality of Alcala, Pangasinan is voluntarily and freely giving, transferring and conveying, by way of Deed of Donation the 3,000 square meters lot to the Province of Pangasinan, provided that the donated property shall be used for the establishment of a government hospital;


