APPROVING SB RESOLUTION NO. 69, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 FY 2024 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO SEVENTEEN MILLION, NINE HUNDRED THIRTY-TWO THOUSAND, TWO HUNDRED TEN PESOS (P17,932,210.00) FUNDED BY THE GENERAL FUND SAVINGS FY 2024"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 69, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 6 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on November 18, 2024 by the Municipal Development Council Executive Committee thru Resolution No. 2024-02;
- 2. Said SIP covers fund augmentation for Personal Services (Granting of Service Recognition Incentive and Collective Negotiation Agreement Incentive to Qualified Government Officials & Employees), Maintenance and Other Operating Expenses and Capital Outlay of some municipal

government offices, and implementation disaster risk reduction and management programs/projects of the LGU; and

3. Funding support for the implementation of the same in the amount of PhP17,932,210.00 is embodied in their proposed Supplemental Budget No. 5 for Calendar Year 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 06, S-2024 on December 19, 2024 and approved by the Municipal Mayor on December 20, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 69, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Supplemental Investment Program No. 6 FY 2024 of the Municipality of Bani, Pangasinan amounting to Seventeen Million, Nine Hundred Thirty-Two Thousand, Two Hundred Ten Pesos (P17,932,210.00) funded by the General Fund Savings FY 2024";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bani, Pangasinan, for its information and guidance.
